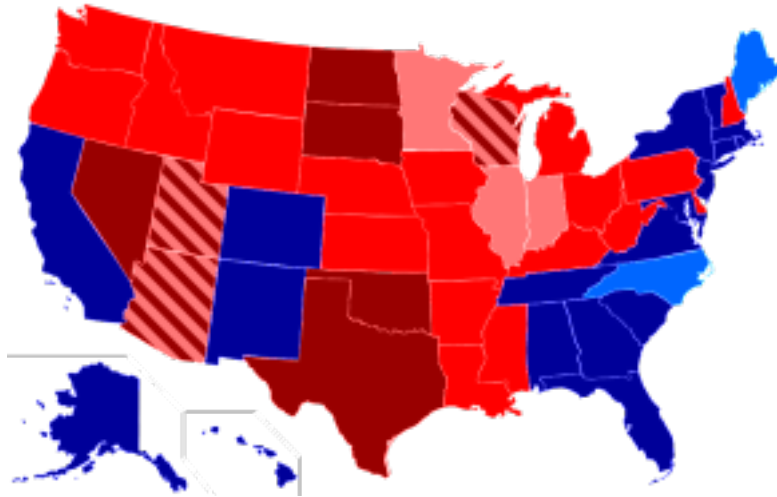


MUSLIM INBREEDING – ISLAM AND JIHAD

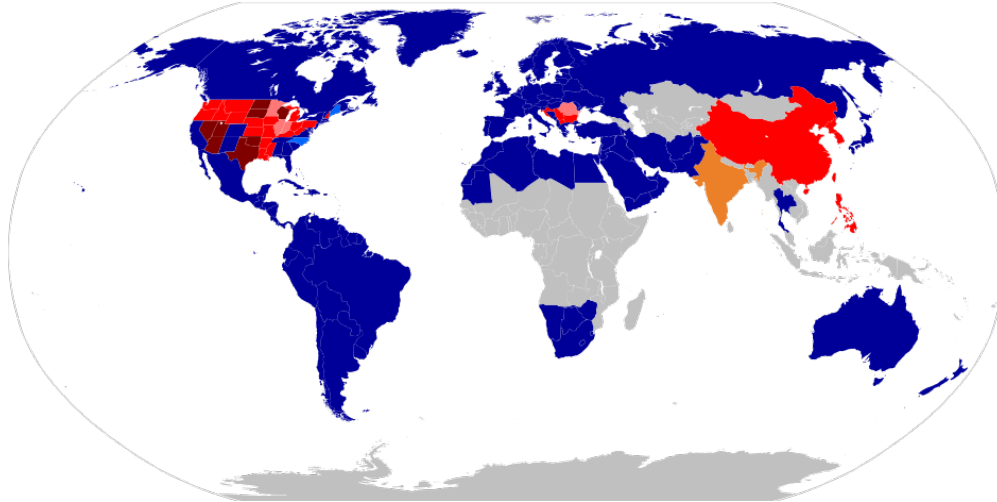
Several years ago, I worked with a Palestinian young woman. After a short while she announced her engagement to her first cousin. In order to have a ceremony performed, they had to go to another state where there aren't restrictions for marrying close relatives. Back in the early 1990's first cousin marriage was illegal in California so they traveled to Alabama to perform their Islamic ceremony.



In the map above, dark blue states currently allow first cousin marriage, red states have laws against first cousin marriage, dark red states call it a criminal offense. In the states with other colors, first cousin marriage is allowed under special provision or disallowed except under special conditions. As I said above, it used to be illegal in California, but with the influx of religions and cultures I can only assume that the law was changed to accommodate those populations, especially where their vote could matter, of course.

As marriage would have it, it wasn't long before this woman became pregnant. I remember her having to go to the doctor an extraordinary amount of times to have tests to ensure that there were no DNA damage to the fetus or danger to the mother. She delivered a little boy nine months later and according to her, the boy was "normal."

Below is a map that shows countries around the world where first cousin marriage is legal or not legal. The color designations are the same as in the map of the United States.



If you do an internet search concerning health problems with first cousin marriages and their offspring, you will find quite a few articles that will say that there is a chance that problems can occur, but the numbers are small and almost insignificant. I also found it interesting that most of the articles came from Great Britain, a nation whose royal families are known for intermarrying for centuries. If you think that Prince Charles looks a little strange, there is a reason. They do go on to mention that the increases in birth defects are found more in the communities that have origins from Pakistan and some African tribes where consanguineous marriages occur. The word consanguineous is Latin and basically means having the same blood ancestry. It applies more to first cousin and incestuous relationships.

We hear a lot of crap coming out of the Middle East (specifically from the Islamic community) and Islamic communities in nations around the world. Some of the things that we hear are totally bizarre to the person with a sound mind and a good conscience. For instance, to have a person declare that Islam is a religion of peace one day and then have them blow themselves up to kill people the next day isn't a sane thing; it is quite insane. To say that the Bible is a great book, and that Christians and Jews are "People of The Book" and then going on a murderous rampage to kill as many Jews or Christians that one can, isn't sound thinking, it is insane. Not protesting when others of your faith are conducting these acts of atrocity isn't sane thinking; no, it is selfish and narcissistic thinking and the reasoning of those who are just allowing their "army" to fight and win battles so that their own militant ways can be hidden for a later date.

The propaganda machine of Islam, that is in favor of consanguineous marriage while ignoring the consequences of such relationships will argue that the birth defect factor is minimal and/or almost negligible and if the numbers are correct, that might be true. However, when the numbers are coming from Great Britain, a nation that does everything that it can to appease its conquerors, you have to wonder if the numbers are right. But, let's assume that the numbers are right and there are a minimal number of birth defects. We'll entertain the propagandists for a moment. The numbers reflect that the children born to those in consanguineous relationships are physically (observably) sound, and that they might even be neurologically sound at birth, but it doesn't mean that they will remain neurologically or psychologically sound. Most mental illnesses manifest in late childhood or early adolescence. It is an interesting fact that this is when militant Muslims become militant.

Environment has been shown to be a contributing factor in the mental and psychological growth of children. People that come from quiet and peaceful homes tend to be quiet and peaceful. Children that come from loud and abusive homes will many times become loud and abusive. Scripture tells us something about Yahweh's dealing with iniquity:

The Lord is longsuffering, and of great mercy, forgiving iniquity and transgression, and by no means clearing the guilty, visiting the iniquity of the fathers upon the children unto the third and fourth generation. Numbers 14:18

Science has confirmed that what the Bible says is true. Let's take for instance alcoholism or drug abuse, something that has been confirmed as being passed down from parent to child:

The Role of Family History

Addiction is due 50 percent to genetic predisposition and 50 percent to poor coping skills. This has been confirmed by numerous studies. One study looked at 861 identical twin pairs and 653 fraternal (non-identical) twin pairs. When one identical twin was addicted to alcohol, the other twin had a high probability of being addicted. But when one non-identical twin was addicted to alcohol, the other twin did not necessarily have an addiction. Based on the differences between the identical and non-identical twins, the study showed 50-60% of addiction is due to genetic factors. [Prescott CA, Kendler KS. Those numbers have been confirmed by other studies. [Enoch MA, Goldman D. The genetics of alcoholism and alcohol abuse. Current Psychiatry Reports. 2001 Apr;3(2):144-51.]

The children of addicts are 8 times more likely to develop an addiction. One study looked at 231 people who were diagnosed with drug or alcohol addiction, and compared them to 61 people who did not have an addiction. Then it looked at the first-degree relatives (parents, siblings, or children) of those people. It discovered that if a parent has a drug or alcohol addiction, the child had an 8 times greater chance of developing an addiction. I often chuckle at how all of the money and time that were spent to make these determinations when all they had to do was read the Bible to come to the same determination. The only difference is that Scripture doesn't give a number to the amount of offspring that will be afflicted. Personally, I have known people that had alcoholic parents and they hated it so much that they have taken vows never to touch the stuff and they haven't, ever. I have also known kids who had parents who were addicted to marijuana and they have done the same thing. So it is possible, I believe, that Yahweh has mercy on those who will respond to that mercy and lets the others slide downhill. He's all knowing anyway, so who am I to question His ways.

I think that it's important that when Yahweh says that his curses go to the third or fourth generation, that it is perpetual. In other words, if generation one is evil and they don't repent, then generation two will be evil, but they fall into the place of generation one, starting the process all over again. Simply put, with each evil generation, three or four more generations are stacked on top of that. If four generations are righteous then the visitation of Yahweh's revenge will end the curse, but if the fifth generation again turns to evil, then the process starts all over again.

If we take into account that Islam was established in or around the year 620, that means that there could be families that have been Islamic for 1,395 years. If a generation is 40 years as many speculate, then that means that there have been families that have been Islamic through 34.875 generations; let's round that up to 35 generations. In some families, the curse has persisted for that long. However, it can become much worse. We know that Abram entered the land of Canaan around 1738 BC at the age of 75. Ishmael was born in 1727 BC and Yitzhak was born in 1713 BC. We know that Ishmael was still with Abraham when Isaac was born because we're told that he was circumcised. He was sent away with his mother the same year, when he

was around 14 years old. If we assume that he married when he was 17 (his mother probably insisted on fulfilling Yahweh's promise) then he could have had children that same year. If we take that year 1710 BC and add it to 2015 AD we come up with 3725 years of contention between the seed of Ishmael and the seed of Yitzhak. If we use 40 as the year of generations, we come up with 93.125 generations, or rounded down to 93. There is a possibility that there have been 93 generations of people who have been cursed because of hatred of the descendants of Ishmael against the descendants of Yitzhak. Some propose that a generation is only 20 years, would double the generations to 186 generations. We could go on and calculate the generations of the two daughters of Lot and their hatred for Israel and/or the descendants of Esau and their hatred of Israel; all of these people neighbors and relatives in one way or another of Israel. The Satanic seed line is wide and deep.

Let's look at how the cards are stacked against Muslim children. First, their parents place their foundation on a book filled with pride and hate; a book that condones murder and torture. The child is born into this world with Yahweh's promise of lack of blessing. The children are brought up in homes where they are told to hate certain people, and that those certain people are murderous thieves (they are told) and this inculcation further jades them and removes any chance of blessing from Yahweh. A Danish psychologist warns that 1,400 years of inbreeding—marrying first cousins—may be wreaking havoc on Muslim intelligence, health and sanity.

*“A large part of inbred Muslims are born from parents who are themselves inbred – which increase the risks of negative mental and physical consequences greatly,” says Nicolai Sennels, author of the book *Among Criminal Muslims* and articles on the psychology of Islam and Muslims, in a Dec. 26 article in 10News.dk.*



Combining his own research and several studies, Sennels says the genetic damage of such intermarriage, which is part of Islamic religion and culture since their prophet, Mohammad, allowed it, is causing lower intelligence (IQs), increased physical defects and greater incident of mental illness.

Almost half of Muslims worldwide are estimated to be inbred, with 70 percent of marriages in Pakistan, 67 percent in Saudi Arabia and 80 percent in Nubia in southern Egypt in consanguineous (blood-related) marriages to first cousins, to name just a few of the countries he cites.

“Several studies show that children of consanguineous marriages have lower intelligence than children of non-related parents,” Sennels says. “Research shows that the IQ is 10-16 points lower in children born from related parents and that abilities related to social behavior develops slower in inbred babies.” And children born of cousins are twice as likely as the general population to have mental or physical disabilities, which drain municipal funds, he says.

“It probably also explains – at least partly – why two-thirds of all immigrant school children with Arabic backgrounds are illiterate after 10 years in the Danish school system...,” Sennels says.

Special education costs for slow learners consume a third of the budget of Danish schools, and Muslim immigrants and their children have a very high rate of unemployment because of limited skills, he says.

Sennels draws broader conclusions. “The limited ability to understand, appreciate and produce knowledge following a limited IQ is probably also partly the reason why Muslim countries produce 1/10 of the World average when it comes to scientific research...” he says.

“The lack of interest in science and human development in the Muslim World is also clear in the UN Arab Human Development Reports (AHDR). AHDR concludes that there have been fewer books translated into Arabic in the last thousand years than the amount of books translated within the country of Spain every year...”

Although consanguinity is lower among Muslims in non-Muslim countries, BBC research recently aired showed 55 percent of Pakistanis in the United Kingdom are inbred, he says, adding that the Times of India reports British Pakistani children are 13 times more likely than the general population to have genetic recessive disorders.

In the article, which is filled with supporting research citations and was originally published in EuropeNews, Sennels says perinatal deaths, some of which are due to genetic disorders, and mental illnesses, such as depression, schizophrenia and insanity, are higher among consanguineous Muslim immigrants than the general populations.

“A legislative ban on first cousin marriages is a logical and compassionate imperative for both the Muslim world, for EU and our Western national governments,” he concludes. [Source: <http://dkgazette.com/muslim-inbreeding-may-genetic-catastrophe/>]
