The drug companies are not feeling this pinch, however. Companies like Pfizer, Moderna, and others will be seen as saviors, the ones that saved the world from the pandemic although the pandemic was dying anyway and would have gone away on its own. Vaccine manufacturers are immune from prosecution. That's right, they cannot be sued for ill effects stemming from their poisons. Half the population could die from side effects of the vaccines and the Big-Pharma will continue to prosper. How is this? Who makes the remedy for the side effects that are caused by the vaccines? Big Pharma does of course. Corporations will pad the pockets of politicians and politicians those of the corporations. In the end, America will look very much like modern China and will devolve to what was once the Soviet Empire.

Schizo – Schizo is an interesting word. Many people equate it with schizophrenia and the root word fits well here. Schizo means “split,” and it is the root word where we get the term schism, which also means split. Interestingly enough, Pfizer does not produce any formulation that treats symptoms of schizophrenia, maybe because the company is the corporate epitome of the word schizo. Medicine is supposed to be dedicated to the healing of people, and many pharmaceutical companies are dedicated to this premise. Pfizer however seems split over whether it wants to

help people or make money while looking like it wants to help people. What I present next is from Wikipedia. It shows how Pfizer always seems to end up in court because it can't decide whether to help people or rob them of money or even their lives. You'll even see that one of the drugs was tested on humans without having gone through rigorous laboratory trials:

Pfizer is a party to several lawsuits stemming from its pharmaceutical products as well as the practices of various companies it has merged with or acquired.

The Quigley Company, which sold asbestos-containing insulation products until the early 1970s, was acquired by Pfizer in 1968. Asbestos victims and Pfizer have been negotiating a settlement deal that calls for Pfizer to pay \$430 million to 80 percent of existing plaintiffs. It will also place an additional \$535 million into an asbestos settlement trust that will compensate future plaintiffs as well as the remaining 20 percent of plaintiffs with claims against Pfizer and Quigley. The compensation deal is worth \$965 million all up. Of that \$535 million, \$405 million is in a 40-year note from Pfizer, while \$100 million will come from insurance policies.

Pfizer purchased Shiley in 1979, at the onset of its Convexo-Concave valve ordeal, involving the Bjork-Shiley heart valve. Approximately 500 people died when defective valves failed and, in 1994, the United States ruled against Pfizer for ~\$200 million.

A federal lawsuit was filed by a scientist claiming infection by a genetically modified virus while working for Pfizer which resulted in her being intermittently paralyzed. "McClain, of Deep River, suspects she was inadvertently exposed, through work by a former Pfizer colleague in 2002 or 2003, to an engineered form of the lentivirus, a virus similar to the one that can lead to acquired immune deficiency syndrome, also known as AIDS." The court found that McClain

failed to demonstrate that her illness was caused by exposure to the lentivirus, but also that Pfizer violated whistleblower laws.

Health insurance company Blue Cross Blue Shield (BCBS) filed a lawsuit against Pfizer for reportedly illegally marketing their drugs Bextra, Geodon, and Lyrica. BCBS is reporting that Pfizer used "kickbacks" and wrongly persuaded doctors to prescribe the drugs. FiercePharma reported that "According to the suit, the drugmaker not only handed out those "misleading" materials on off-label uses but sent doctors on Caribbean junkets and paid them \$2,000 honoraria in return for their listening to lectures about Bextra. More than 5,000 healthcare professionals were entertained at meetings in the Bahamas, Virgin Islands, and across the U.S., the suit alleges." The case was settled in 2014 for \$325M.

Controversy arose over the drug "Celebrex". Brigham Young University (BYU) said that a professor of chemistry, Dr. Daniel L. Simmons, discovered an enzyme in the 1990s that would later lead towards the development of Celebrex. BYU was originally seeking 15% royalty on sales, which would equate to \$9.7 billion. The court filings show that a research agreement was made with Monsanto, whose pharmaceutical business was later acquired by Pfizer, to develop a better aspirin. The enzyme that Dr. Simmons claims to have discovered would induce pain and inflammation while causing gastrointestinal problems, which Celebrex is used to reduce those issues. A battle ensued, lasting over six years because BYU claimed that Pfizer did not give him credit or compensation while Pfizer claims it had met all obligations regarding the Monsanto agreement. This culminated in a \$450 million amicable settlement without going to trial. Pfizer said it would take a \$450 million charge against first-quarter earnings to settle.

Nigeria Trovafloxacin lawsuit

Main article: Abdullahi v. Pfizer, Inc.

In 1996, an outbreak of measles, cholera, and bacterial meningitis occurred in Nigeria. Pfizer representatives and personnel from a contract research organization (CRO) traveled to Kano to set up a clinical trial and administer an experimental antibiotic, trovafloxacin, to approximately 200 children. Local Kano officials reported that more than 50 children died in the experiment, while many others developed mental and physical deformities. The nature and frequency of both fatalities and other adverse outcomes were similar to those historically found among pediatric patients treated for meningitis in sub-Saharan Africa. In 2001, families of the children, as well as the governments of Kano and Nigeria, filed lawsuits regarding the treatment. According to the news program Democracy Now!, "researchers did not obtain signed consent forms, and medical personnel said Pfizer did not tell parents their children were getting the experimental drug." **The lawsuits also accuse Pfizer of using the outbreak to perform unapproved human testing, as well as allegedly under-dosing a control group being treated with traditional antibiotics in order to skew the results of the trial in favor of Trovan.** While the specific facts of the case remain in dispute, both Nigerian medical personnel and at least one Pfizer physician have stated that the trial was conducted without regulatory approval.

In 2007, Pfizer published a Statement of Defense letter. The letter states that the drug's oral form was safer and easier to administer, that Trovan had been used safely in over 5000 Americans prior to the Nigerian trial, that mortality in the patients treated by Pfizer was lower than that observed historically in African meningitis epidemics, and that no unusual side effects, unrelated to meningitis, were observed after 4 weeks.

In June 2010, the US Supreme Court rejected Pfizer's appeal against a ruling allowing lawsuits by the Nigerian families to proceed.

In December 2010, WikiLeaks released US diplomatic cables, which indicate that Pfizer had hired investigators to find evidence of corruption against Nigerian attorney general Aondoakaa to persuade him to drop legal action. The Washington Post reporter Joe Stephens, who helped break the story in 2000, called these actions "dangerously close to blackmail." In response, the company has released a press statement describing the allegations as "preposterous" and stating that they acted in good faith. Aondoakka, who had allegedly demanded bribes from Pfizer in return for a settlement of the case, was declared unfit for office and had his U.S. visa revoked in association with corruption charges in 2010.

After reading the above, could anyone seriously allow an injection from such a company to be placed deep in an arm muscle, especially since like above, the injection is untested? Not me.

Jeanie – Jeanie Walls is the Senior Regulatory Affairs Manager at Pfizer Australia. She has also worked in the field of research and development for Pfizer during her 18-year career at Pfizer Australia. A senior regulatory affairs manager is responsible for working with government officials that are in charge of governmental regulations for product distribution. In layman's terms, she tries to do everything that she can to ramrod through the approval of Pfizer products. Having experience in research and development goes a long way to equip someone with the scatological terminology to convince governmental authorities to quickly approve a product, like the COVID-19 vaccine, which was approved by many governments although it never went through animal testing. Like we read in the last description, Pfizer likes to introduce medications to the general public without fully testing the product.

Gargoyles – Gargoyles can be found on many medieval buildings. On some buildings, they are used as gutter spouts that direct water away from the building. On other buildings, such as churches, they were often used as a superstitious method of warding off demons and other evil beings. The interesting thing that gargoyles exhibit is that they are often chimera-looking creatures, having the form of two animals, many times human-looking figures with other animal features. What I think is noteworthy is that some very intelligent people oppose the mRNA vaccine, stating that it changes the DNA of the person that receives the vaccination, technically this makes them chimera since they are a combination of two different species. The modern term that many endorse as a reference is animal/human hybrids.

- *Photographic memory*
- *Past life memories*
- *Manipulation of time and space*
- *Information that they have not consciously learnt*
- *Downloaded information, “knowledge bombs” which may cause headache*
- *Able to see with various parts of their bodies*
- *Strong sense of purpose and mission*

There is a new phrase that is being used for something akin to Homo Noeticus, that being Homo Deus, which translates from the Latin to be “Man-God.” While Homo Noeticus seems to be a leap in evolution based more on a spiritual foundation, Homo Deus is used to denote evolution through technological means. A good definition of Homo Deus reads:

Homo deus, “god man”, is a way to describe a potential next stage in human evolution where we control our own destinies and further evolution rather than being shaped or limited by nature’s mechanisms of life.

This could mean attaining immortality, for instance, through the use of replacement organs, cybernetics, gene manipulation, computerised brain emulation, or a combination of all these and other means of extending life.

Though the term may be relatively new, science fiction writers have long toyed with the philosophical ideas and consequences of man being able to shape their own biological evolution and thus becoming their own gods, in a sense.

In either case, the idea is based on enhanced DNA and one has to ask if the beginning of this enhancement is via an injection that is supposed to protect mankind from a Plandemic formed to coerce men into taking the vaccine using covert means.

One thing that I found of interest came to me via a local newspaper, published in Albany, Oregon. The article was borrowed from other sources by the paper. From what we have learned about Pfizer and its underhanded ways, it must have been dealt with in the negative aspect. Pfizer, with its Novel Covid-19 mRNA vaccine, was birthed in rebellion. It has led to subversiveness in the pharmaceutical community and the new approach that it has used is injecting humans as test animals without any trials in the lab or animals.

Heron's Formula – In geometry, Heron's formula, named after Hero of Alexandria, gives the area of a triangle when the length of all three sides is known. Unlike other triangle area formulae,

there is no need to calculate angles or other distances in the triangle first. There are problems with this formula.

John D. Cook argues: Heron's formula computes the area of a triangle given the length of each side. If you have a very thin triangle, one where two of the sides approximately equal “s” and the third side is much shorter, a direct implementation of Heron's formula may not be accurate.

Now equate this with Pfizer’s mRNA vaccine. By the formula that they used and by the reasoning that they have adopted they purport that their vaccine is viable. However, they took many shortcuts, just like Heron’s formula is a shortcut, but like most shortcuts, you chance not producing the intended results.

Now in English: In Biblical eschatology this theorem is what is used when the Man of Perdition is mentioned in Revelation. So, what does this mean when it comes to Pfizer and the mRNA vaccine? It means that if they used it to manufacture the vaccine it will come to nothing.
