

# **SHOULD A JEW TAKE THE COVID-19 VACCINE**

I have never been one to knowingly let government and/or organizations push something on me without researching how it will affect me and/or my family today, tomorrow, and much farther down the road. Now, whether my friends and family listen to my findings is another story. I have to admit that I am a bit militant when it comes to research and trying to get people to understand an issue and how it impacts them as well as myself and that has, I think, caused some people to think that I am overbearing and unreasonable when it comes to some things. I do however take the office of Prophet seriously, and if I am standing on the wall and I see an enemy approaching, I will cry out that we are under attack, so to speak. This is the mission that Yahveh has given me in this life and I will fulfill it, whether people like it or not. The difficult thing about this mission is watching people turn away from warnings and valid research and then watching them suffer the consequences of their actions.

In January of 2020, my wife and I were returning from Florida where we visited my mother for a week. We looked forward to getting home and being reunited with our four dogs

and our very comfortable bed, and we weren't going to miss the Florida humidity one bit. Yes, it is still humid in Florida in the Winter. We landed at O'Hare Airport after which we disembarked from our plane and found out that we had to move over two concourses to get to our next gate, our last flight which would take us from Illinois to the airport in Eugene, Oregon. We arrived at the gate in O'Hare and witnessed a woman laying on a stretcher. She appeared to have labored breathing and was wearing an oxygen mask. Thinking that she might have had a heart attack or some sort of panic disorder we prayed for her. Soon afterward they wheeled her away on the gurney. The thought of COVID-19 was still very new here in the States and we never thought that this woman might have been one of the first cases that were reported on the news. While we were on the plane we were able to get the news that one of the first confirmed cases had been at O'Hare that day. I thought about all of the surfaces that we might have shared with this woman, but like most, we dismissed the notion.

Around the first of February, we both came down with some sort of sickness. To be honest, it was like nothing I had ever experienced before. Bear in mind that I have had several bouts of bronchitis, three bouts of pneumonia and when I took flu shots in past years, I always seemed to have a sick flu season. So I have had quite a few experiences with bronchial and lung ailments. This thing however was different. I could feel phlegm rattling down in the bottom of my right lung. I did my lung exercises which have always worked in the past. I breathe in deep and take long exhalations that have always brought up phlegm in the past. One day, however, I did these exercises and I experienced a strange feeling at the bottom of my right lung, best described as feeling as if my lung had separated from whatever holds lungs in place. This scared me because it had never happened before and it caused me to cease the lung exercises for fear

that I had damaged something down in my chest. I then began to fear because when you cannot exercise the lungs the possibility of pneumonia becomes much more real.

After a few days of fevers, dry coughs, headaches, shortness of breath, and other symptoms we started to feel better and after about two weeks we both felt like we were over what we had. I never did find out if I had COVID-19 because at this point in the Epidemic nose swab tests were very hard to find and when I did see the doctors he and others surmised that I didn't have COVID-19 but something else that they could not identify, so they sent me home.

One of the symptoms that never left me, and that still bothers me is that I am short of breath much of the time, especially during walks and if I try to speak long sentences. Also, my voice has changed and I take on a Rod Stewart voice many times. There are oftentimes that I have unexplained fevers, or a dry cough, and of course the shortness of breath. For a long time, I just wanted to lay around and do nothing. I found myself sleeping much of any day. I fell asleep at work two or three times. Even today these things occur. When I do manage to feel good enough to put in a week's worth of work I come home from my job and nap for two hours, only to have to get up to shower and return to bed. My first day off for many weeks was spent sleeping the day away. In a sense, I am not the same person that I was 15 months ago. Yes, I am 62 years old now and I consider myself a survivor, not only of cancer and other ailments but also of two bouts of COVID-19. Yes, I got it again at the end of May of 2020. I missed so much work the last half of the year that I lost some benefits at work and have been told that I have to consistently work to get them back. I have applied for ADA at work, but for some odd reason, Human Resources is sitting on the application, almost as if to punish me for all of the time that they paid me for being sick last year. Funny, it was work that sent me home because of their COVID-19 protocols yet I am at fault for being sick with COVID-19 and a syndrome that comes with it that is called

COVID-19 Long Haulers. People like me somehow have flareups of symptoms over and over again causing, in my case and maybe others, being screened out from work again. Oh, and because there are people who have taken advantage of the protocols, my workplace has changed them several times and we have to cover missed time with our own time, which many of us have exhausted.

The only saving grace is that work has not mandated that everyone has to take the vaccine. Quite a few have declined, many because we do not want to be lab experiments for a vaccine that the FDA still hasn't certified as viable. Also, many like myself have preexisting conditions, me with my lung issues, and others that have autoimmune issues and such. What Human Resources at our hospital are putting those of us with preexisting conditions through is shameful and immoral. Aside from the preexisting conditions, which for me are the lungs, a heart issue, being a cancer survivor and yes, I'm a bit overweight, there is a religious component to my refusal to take this vaccine or any vaccine for that matter.

I have been an anti-vaxxer for many years. I am not in favor of putting heavy metals into my body, which most vaccines contain. Aside from that, rumors of using fetal stem cells from murdered babies and DNA from other species have factored into my decision.

In defense of my religious declination, I searched the internet for Rabbinical reasons why Jews should not take the poison that they call the COVID-19 vaccine into their bodies. I know the reason, but I wanted to ask Rabbi's what they thought of the matter. To my surprise, (or is it a surprise) most Rabbis are in favor of Jews taking the vaccine into their bodies. Their reasoning is a Talmudic tradition that it is a Mitzvah to save a life. They assert that taking the vaccine could save your life, and if you cannot get COVID-19 after taking the vaccine you are saving other

lives. They do not understand that there is no hard evidence that taking the vaccine will inoculate humans from the virus.

I started my pursuit of Rabbinical knowledge by contacting the “Ask The Rabbi,” feature at the Chabad.org website. What I got was the usual “Mitzvah” talk. Here is the conversation that I had with a Rabbi. Out of courtesy, I will not divulge his name:

*Chat With Chabad Rabbi*

*On Monday, February 8, 2021, you wrote:*

*I have been researching the viability of we Jews taking the COVID-19 vaccine. It is noted in many places that the ancients in the antediluvian world mixed animal species and that this is one reason why G-d wiped out all flesh from the earth. The new vaccines take a snippet of DNA from the COVID-19 virus and it causes the body to react, but immunologists say that it is still an unproven technology. So although we may be performing a mitzvah by keeping ourselves well and protecting others, aren't we performing the same act as the ancient's did before the flood, the mixing of organisms?*

*The Reply That I received:*

*B"H Hi David, It is true that one may not mix species. Yet, that is referring to breeding, I can cook a chicken and beef stew together. Additionally, if not most important, one may violate most Torah commands to save a life. Please don't hesitate to write back if you have any further questions. Best wishes, Simcha Bart Chabad.org*

*My Reply To The Rabbi:*

*I understand your premise. The mixing of animals in breeding brings together DNA codes from one species to another. The mRNA vaccine uses a snippet of DNA from a virus that goes into a human cell changing the cell from human to hybrid which is neither human nor virus but mimics a virus so that the body creates antibodies. Some scientists fear that the body will create antibodies to attack the human aspect of the cell. If a person takes something into the body that is injurious and it kills the human wouldn't that be a form of suicidal ignorance? In either case, isn't it a mixing of species seeing that hybrid cells are formed that G-d may have never intended to exist? I'm not trying to cause trouble, but these questions I feel are valid ones?*

*The Rabbi's Reply Back To Me:*

*B"H Hi David, As I said, if it's too save a life, one may violate almost all Torah prohibitions. As far as it bent suicidal, that's not the job of Rabbis to decide if something is beneficial or dangerous, one needs to follow common medical advice. Please see <https://www.chabad.org/2870103/> about the general idea of vaccines and following the accepted forms of medical advice. As you can see, it was starting to turn into a circular conversation on his part, so I broke off communication. When I received his last reply my mind was immediately brought to the scripture that states, "for lack of knowledge, my people Israel perish..." At the very least, my questions should have caused the Rabbi to look into the matter, to consider what I have proposed. He could have given it to a higher rabbinical authority or consulted and cited Torah or the sages. I was disappointed that he didn't address the idea that if a person injects something harmful into their bodies and it kills them isn't it suicidal ignorance? His advice is flawed in

many ways. Let's surmise that we run into a doctor that is a psychopath, maybe like a doctor Kavorkian or some of that like. We tell this doctor that we feel terrible all of the time, are wracked in pain, and have a poor quality of life. He draws something into a syringe and tells us that with that shot, all of our problems will go away and we will never hurt again. What we do not know is that this doctor has drawn up a lethal amount of potassium chloride and he injects it into our vein. Within a matter of minutes, we fall into a coma-like state and soon we die from heart failure. Well, the doctor didn't lie. He gave us something that took away all of our problems, our hurts, pains and if we have faith in Yahweh, our quality of life has increased leaps and bounds because we're in paradise. We followed what we thought was common medical advice from a person that we thought was a knowledgeable doctor. He had several diplomas on his walls as well as several awards for excellent medical service, right? According to the Rabbi's advice, this would be the sensible thing to do, follow the advice of a common medical professional, right?

What was equally disturbing was the comment that the Rabbi made, stating that it is not the job of Rabbis to determine if something was beneficial or dangerous. Here, he was contradicting himself because in an earlier conversation he said that taking the vaccine was beneficial (a mitzvah) because it would benefit me by keeping me from getting sick and benefiting others. After all, I would not get them sick. In the same vein, he was suggesting that not getting the shot violated Rabbinic Tradition because I could get sick, or get someone else sick by not taking the shot. I loved too the game of hot potato that he played by passing the buck off to a website that could educate me more. If that is where he got his education there was no need to visit that link seeing that I was getting dizzy from all of the circular reasoning.

Thinking about this is soon became even more apparent why our people in Europe allowed the Nazis to round them up, cart them off into cattle cars and take them to extermination camps. I envisioned a group of European Jews at synagogue asking their rabbis what to do about the mobs of people on the streets burning their stores, stripping them of their possessions, their livelihoods, and enduring the harassment of the Nazis before they were taken away. I envisioned their rabbis telling them that this was beyond their expertise, that they needed to just trust that the current trend would end soon, those good Germans, good Frenchmen, good Poles would rise up and put an end to the persecution. They probably surmised that the goodness in men would shine and that they would be delivered by good people. Their remnant was delivered, but not for a few years and they were delivered, the remnant that remained, but not by their good Gentile neighbors, but by Allied Soldiers that fought and prevailed over the Nazi murderers.

About this same time I remembered that during this COVID-19 event Christians have fallen into the same trap that the Jews in Europe fell for. Christians are told in the Brit Hadasha that they should honor and pray for people placed in high office because Yahveh has placed them there. It is because of this very scripture that Christians closed down their churches for the supposed pandemic. Of course one doesn't have to be reminded that much of the Christian dilemma has to do with the 501c3 status that they place themselves under. If they disobey the government then the government removes the 501c3 and parishioners cannot write off their tithes at tax time. If they cannot use their tithing tax shelter then they stop giving many times. When they stop giving the pastor doesn't get paid, the church mortgage becomes delinquent, and the richer people in the church who were there because of the write-off at tax season stop going to church. Many of them, because they were heavy donors at the church are not there anymore

and the church loses its structure because the rich people were quite proficient in delegating church spending, but there is no more money so the church collapses.

People have a torsioned idea of who Yeshua is and what the early church was. The ideals that Yeshua preached in his day were considered revolutionary. He was bucking hundreds of years of oral tradition in favor of Torah adherence. He called out the religious leaders of that time and whipped the money-changers as he turned over their tables, calling them a den of thieves. Today's pastors and church administrators have made the government their master, but Yeshua is kept around, stuffed in a corner until He is needed for prayer needs. It is shameful.

Getting back to the mRNA vaccines. What I have explained many times is that the human body can be fooled into thinking that something is, in reality, something else. This very aspect is the reason for the autoimmune diseases that exist. The body is tricked somehow into fighting against itself. When the mRNA vaccine is injected into a human body the spikes of the virus enter into human cells which produce more protein spikes. This causes the body to want to fight the protein spikes which causes the human body to create antibodies to fight the invader. Who's to say that these vaccines won't cause an effect where some human bodies will be fooled into thinking that the human cells are the invaders, causing the body to create antibodies to fight against the cells instead of the viral protein spikes? Remember, this vaccine was rushed through the testing process and wasn't tested on laboratory animals first like most vaccines. Humans receiving the vaccine are lab-test animals. Yes, I mentioned all of this earlier in this article, but sometimes (like a nail) has to be struck twice before it is hammered home.

Today I saw a doctor because I had another bout of Long Haulers last weekend. We talked about the vaccine. The doctor said that she was not in favor of the vaccine, but thinks that she will protect her patients from disease, and she seemed sincere and that makes her a noble

person to me. However, she is like most doctors who are not willing to buck the system so to speak. Just like Soviet Russia, in medicine, doctors, nurses, and others have to tow the party policy and jargon. She understood that I am against the vaccine for religious reasons, but could not fathom why I saw it as mixing of organisms. Doctors, like so many others, have to do what they're told and believe what they're told. They make good money, have high mortgages, and have to pay off student loans and such, and I understand that. And remember, that if they speak their mind, there is always one useful idiot that would love to run to their superiors to report them for not towing the party line. I found that out personally. So when your doctor tries to "educate" you about the vaccine, don't fall for it, but understand that just like a computer, a doctor takes in information that is fed into them. They are a database that draws from other databases and it is easier for them to remain that way, both professionally and economically than to step out and process all aspects of information. They see your opinion as malware and you just have to accept that and give them a good reason why you process the information the way that you do.

Right now as I write this, there is a group of Israeli's that are petitioning the World Court at the Hague to stop the government of Israel to force vaccinations on an unwilling public. The following is a post that I received from a family member in Israel regarding that matter:

Stand up for your rights. They are yours!! These are neither tests nor vaccines!!! And about a criminal lawsuit filed in The Hague:*

*Israelis sue Netanyahu at the Hague International Court, claim: 'Israel civilians participated in a genetic-medical experiment'*

*Israel has become one of the first countries to put into force a COVID passport system that will allow people to participate in social activities - including trade - only after they receive the vaccine and have been approved to join the system.*

*Now, a group of Israeli Jewish lawyers, sues Netanyahu in the Hague International Court, claiming that Israel violates Nuremberg's ' code of medical trials by claiming " putting Israelis under a medical experiment through vaccines as a condition for participation in civil life ".*

I have argued in the past that forced vaccination with any vaccine, especially the mRNA vaccine violates the Nuremberg Code. Isn't it ironic that the very people who were subjected to immoral and unethical medical tests during the Nazi regime are being subjected to the same unethical treatment by a Sabra who, in my opinion, is just another Elitist puppet? We need to

pray long and hard that the World Court finds in favor of these lawyers and doctors that Israel has sent to them. The outcome of this trial could impact the world for years to come. You know, for years I never gave validity to anything that came out of the World Court, but this piece of jurisprudence could turn the Big Pharma empire upsidedown. Right now in Israel, you cannot travel unless you have a card saying that you have been vaccinated. If not vaccinated you have to stay in your home and you can only shop at certain times. You cannot get on an airplane without your special ID. Our kids cannot visit us, although they have the means, simply because Netanyahu and his Brownshirts have placed ridiculous demands on the population.

In my efforts to explain to people that this vaccine is dangerous, I've been scoffed at, called a nonconformist, dangerous, and other things. Do I think that the vaccines have nanobots in them? Well, they might have them. Do I think that the mRNA vaccines will change human DNA? Yes, I do. Do I think that the vaccine makes the person injected a hybrid? It's quite possible. Do I think it's dangerous? Hell Yes!! Will I ever take it? Hell No!! What will I use as a defense? I will argue that it violates Torah, Leviticus 19:19 to be exact and that my faith in YHVH will keep me safe and sound as He will my family and friends.

I realize that Rabbis are ignorant, as are Christian leaders, but both have flocks that they have been bad shepherds over and they will be held responsible on the last day. There are Jewish Rabbis out there who are against the vaccine, but they are ostracized by the higher elitist rabbis. One of those rabbis is Rabbi Yuval Hacoheh Asherov from Israel. He argues against the vaccine because it damages the Human immune system. Here is a transcript I made from his speech about the mRNA vaccine:

*Rabbi Yuval Hacoheh Asherov*

*Rabbi Yuval Hacoheh Asherov of Ohr Haganuz answers questions asked by followers.*

*Hello Friends. Another Short class on the topic of the vaccines.*

*The Corona vaccine is something that, in my opinion, is not talked about enough.*

*I don't understand why it's not talked about enough. Maybe because in fine print, are all the relevant documents.*

*But it needs to be talked about a lot more because that is in fact the main thing that prevented approval of vaccines in the past. Approval of vaccines from the same type as corona. And that's an occurrence called ADE. ADE.*

*ADE stands for Antibody-Dependent Enhancement. Translated into Hebrew, antibodies are antibodies.*

*Enhancement is deterioration or exacerbation. Meaning, it's the exacerbation of a disease. An exacerbation of what is happening in the body. That is dependent on antibodies.*

*And the truth, and this occurrence which is called ADE, is the main reason according to what the scientists are telling us. And Again, I am saying that these are not my ideas. I am only giving dry facts to the public.*

*I think that because they are presented in not the most popular ways, so people don't read these things. But here, there is a substantial danger.*

*For example, the two ex-head scientists from Pfizer, named Dr. Yeardon and Dr. Wodarg who sent out an urgent letter to EMA which is the equivalent to the FDA in*

*Europe, a letter of warning about the Corona Vaccine. They say that one of the main risks, that, they didn't approve these vaccines until today, with the occurrence of ADE, and before they are tested on humans, they should be tested on animals. Soon, I will explain why it isn't logical to be tested on people.*

*But I am translating what they say. This is a translation from their letter and everything. We will give you sources and quotes and you can read everything that I say and you can critique what I am saying.*

*The problem with the ADE is the main reason why many previous trials of other vaccines for viruses like these failed. Big safety concerns from what was witnessed in animal models. Meaning, they tested vaccines from this type and claim that these vaccines... That this occurrence of ADE appears as a reaction to the vaccines against viruses like Dengue; like the Ebola virus, the HIV virus, which is the infamous AIDS disease. And, all of the viruses which are from the family of Corona. Meaning, the occurrence of ADE is an occurrence which is observed and known.*

*I am prefacing by saying, there is no argument that this occurrence exists. Between all of the scientists that you will read, and all of the articles you will read, from all over the world. There is no controversy if the occurrence exists. There are four or five theories, on how it exactly happens in the body. But it doesn't really matter for our matter, because, what matters to us is, it is happening, or not happening.*

*If the occurrence of ADE is happening, so, anyone who takes this vaccine is in danger. Not according to me. They aren't my words. According to who developed this vaccine and soon I will read you what they write. Before I read it to you, I just want to*

*explain in simple words, so it will be clear to all, all of us who aren't scientists. Whoever hears us and isn't so knowledgeable, on this matter of ADE. What is ADE?*

*ADE is an occurrence which has been observed for years. For about thirty years they have been investigating this thing. And 13 years in a more concentrated way. In the last few years. There is a paradoxical occurrence where a person gets vaccinated, or in this case, animals got vaccinated against a certain disease. The reaction to the vaccine is that the antibodies go up and the body responds well and attacks the antibodies, sorry, it attacks the protein that it needs to attack. But after a period of time, where the first stage passes, of a month or two. A few months after getting the vaccine when the amount of antibodies in the blood begins to go down, an occurrence begins which is very unclear, which is an intensification of the disease for which he was vaccinated. But the body doesn't have what it needs to do against the intensification. It's a very strong intensification, mainly in the respiratory system. Extremely severe pneumonia and from the spread of inflammation in different organs of the body to difficult diseases which can lead to death. Meaning, in the testing they did until now with vaccinations of this sort.*

*Again, these are dry facts. It's written. Read in all of the sources we will give you. Tens of articles. From tens of professional doctors. All of the experiments that were done until now in this area, you know, every experiment has to get approval from the FDA, the Food and Drug Administration. They approve every drug and food in the United States. There is a parallel one of it in Europe (EMA). All of the experiments stopped at the animal stage. There is a stage of laboratory experiments on tissue in a lab, then they move to the third stage with animals. They test it on three types of animals, cats, mice and monkeys. In the first stage, let's take the experiments of the monkeys which is the*

*experiment that stands out the most in the literature. In the beginning, the monkeys responded very nicely to the vaccine. The antibodies went up, and they dealt with the spike proteins. But after five to seven months in all the monkeys there started appearing difficult pulmonary diseases and widespread inflammation in the body, where, there was nothing that could be done for them. All of the monkeys died, one after the next. The same goes for the cats and the mice. Therefore, never were the experiments of vaccines from this type, which I read in the beginning never passed onto the experimental stage on people. NEVER! And therefore, it was never approved.*

*What they informed us of this time with the corona vaccine that they did do experiments on animals. Pfizer gave out very little information but very vague, on a very limited amount of animals for a very limited period of time. I cannot tell you exactly how long because the information was very foggy. What we do know is that they immediately started trials on humans for a few months. Limited, to the amount of a few ten thousands of people from sections of populations that are very limited. This we know. But to get information on these experiments, also some of them aren't shown and some of them are from the control group and they received the original vaccine. We can't even know if there is no control group. This experiment for us was as if it never happened because it's completely irrelevant. To say that there is no occurrence of ADE in the current corona vaccine, that's a joke. No one checked it over a period of time, not on monkeys, not on humans*

*The experiment is happening now. Whoever got the vaccine now, he is actually the guinea pig and he mainly serves Pfizer. For them, it's literally to lick their fingers that so many people get a vaccine that isn't approved. Now, what happens? The FDA you*

say, “wait, Master of the World these things are known in science.” Everyone knows it. How did they approve it? It’s clear. Here this document from the two head scientists and Professor Delores Cahill. I won’t start reading it to you. You will receive the sources in this clip and you can read everything I am saying here to see it is right. Everyone is warning that there is a serious problem here. You say, wait. How can they do that? How are they doing that? At least you would say that the FDA or Pfizer would deny it and say, “No Way! It’s not true.” “There’s no such thing. It was like that with the monkeys, when they checked Ebola.” “But it isn’t so here. Here we didn’t find that.” Pay attention, these things are written. I’m not, heaven forbid, making anything up. Go into the documents of the FDA which approved the emergency approval for the corona vaccine. This is, by the way, they never approved the vaccine. They say when they will approve it, and ‘whoa unto us’ if they approve it, as they say, but they say that they never approved this vaccine. On page 49, in the FDA documents, I will translate it now, and you will also have it in English. You will be able to read it and see that the things appear. They say that Pfizer themselves reported that the occurrence of the ADE wasn’t observed. Wasn’t observed. They didn’t see this occurrence take place. When didn’t they see it? It must be noted in the three months that they tested humans, we said that this occurrence begins after half a year. That’s how it was documented in the research. It appears after half a year when the amount of antibodies in the blood goes down. So, they said that they didn’t find, they didn’t see the occurrence of ADE.

But pay attention as it goes on. The FDA itself writes, however, the FDA informs that the risk of the occurrence of ADE wasn’t ruled out. You heard? The risk of ADE occurring wasn’t ruled out. The FDA must note it. They are the inspection. And it is a

*rick which must be evaluated and observed in experiments which will take place, not that already took place, but that it will take place. Yes? Which must be evaluated and observed in experiments which will take place, after giving approval for the use in emergency. Do you understand what is written here? That afterward they will give approval to give these shots to the whole world, to whoever wants. Soon we will see that not everyone will take it. Then tests will start. On who? On monkeys? No, we don't need monkeys anymore. And then they need to approve it, meaning, whoever gets the vaccine now is exposed to a serious risk, according to the FDA.*

*If that's not enough, there is something else that Pfizer reported. That's what the FDA writes. Pfizer reported on a medical surveillance program. It is called PVP, a complicated word in English. A medical surveillance program of supervision regarding risks which are possibilities in connection to the vaccine for Covid 19 from Pfizer. Here is the significant part. Pfizer identified an advanced disease that is connected to the vaccine. It is called ADE including increased pulmonary disease which is linked to the vaccine as a significantly possible risk. Listen closely. Pfizer identified ADE as a significantly possible risk. In a previous part, we said that they didn't witness ADE. Obviously! They didn't see it on people because they tested it for three months. But they have to write it. Pfizer writes it that ADE is a significantly possible risk, meaning, that they can't say that it isn't. All of the scientists know this thing. All of the scientists know this thing. Therefore, on page 49 of the document again what is written? I will only read the significant things. This information doesn't point out a risk of an enhanced disease, as a result of the vaccine. On the other hand, it shows effectiveness against illness within the*

*time of the testing. The three months that they did. Together with that, there is a risk of an enhanced disease, as a result from the vaccine over time.*

*Again, ADE, a risk of an enhanced disease as a result of the vaccine over time can occur from a situation of lessened immunity; what we said, that the antibodies go down, is left unknown and we need to estimate this risk in the future in clinical trials and observational studies so that they can estimate after approval is given, or a license. Meaning, after they approve it. What does that mean? Okay, give the world this vaccine as an emergency and whatever will be will be. After we get through this time period, we will start experiments and see if we will approve this vaccine. Vaccination approval, not emergency approval.*

*What comes out here friends? From these excerpts, I am reading to you from the FDA and from Pfizer. I am not reading crazy things. I am not saying my opinions at all. I give my opinion at the end as to what I think you need to do. Me, the small one. It doesn't even matter what I think here. It really does not matter what I think here. What does it have to do with us? It has to do with us because these things are happening now, and the public simply needs to know. Why doesn't the public know? Probably because it's written in English in documents, hidden there on page 49. Read the Risk Assessment from the documents of the FDA, the Risk Assessments of Pfizer company and you will see there in a small line. They have the immediate risks, the middle risks, and the last row on the bottom, there are small lines, Risk Assessment, yes? Enhancement. They write it. There is a risk of worsening of antibody dependence, ADE, ADE.*

*At any rate what do you see? That this thing was not completely not discounted. If someone can look me in the eyes and tell me that there is no risk here? That we aren't in*

*danger? Now, take 50% of what I said and erase it. Take 50% of the articles and say that people went crazy and it isn't okay. What? We don't need to worry? We need to be the whole world's guinea pigs? To take something that they say has a risk? Understand, animals died one after the next. Say, okay. God willing. I am the first to pray that it doesn't happen. And if it's a mistake, I am the first to get up and say that we were wrong. It was all fake. There was confusion. But it doesn't look like that right now. Now it looks like we have to be worried about it.*

*What will the vaccine 'followers' say? What will they say? They will say, "Yes there is such a thing as ADE, but not with Corona." So, these documents completely take down their argument. If they say that it exists but it isn't a significant risk, they should read very well the fine print of Pfizer and the FDA. Significantly possible risk. They aren't writing it for no reason. They could have written "risk." They could have written "possible risk." Why did they write, "significantly possible risk," to say that it is wrong?*

*Another claim that they have is that the corona is more dangerous than the vaccine. Let's say if there is a risk in the vaccine so the death from corona is more dangerous. I will disprove it in seconds through tables and reports from the ministry of health itself. How many deaths from the flu, from this corona? What they say is completely unfounded. That is why the public needs to wake up and read about it and to understand. Soon I will tell you what I think you need to do.*

*Now another thing that I would say about all of this around the corona vaccine, if it's really something that saves lives, do we really have, do we really have; okay, I don't have it here. I don't know where it is. Does this vaccine actually save lives? Everything we bring is from verified sources. There is a known British newspaper, BMJ on matters*

*of medicine, says that there is no evidence that this vaccine saves lives and there is no testing which checks it. Does it lower the cases of admission to the hospital, ICU and cases of death? If so from everything I said here in short, we can go on and on about it. We can talk about the ADE and the mechanism it works on. There are whole reports on it. I don't want to burden the public. I just want to say one thing. There is no doubt here to anyone with a mind, who reads these things. Even a small child can read it, that there is a substantial risk here to everyone who takes it.*

*We are at risk where (reflective look). Look, the only way to get out of it in the future... because it will happen? What will happen, according to what they say? According to what scientists say? The moment that the antibodies go down in the blood the ADE begins. And then it's life-threatening. The only to get out of it is to take another vaccine which will elevate the amount of antibodies again. And then the ADE will go down and then again after a few months, again, the antibodies will go down. Then, another vaccine. Then the antibodies go down again and again another vaccine shot. For how long? For how much time? That's what the scientists predict will happen. Trapped in vaccines for their whole lives? More and more and more. Everything I am saying is a possibility. And I said it again. Erase half of what I am saying. Say it's all foolishness. I ask that whoever responds and says that I am saying foolishness, responds directly. Meaning, bring documentation. Bring studies. Don't say that it doesn't seem like it... And so, on and so forth. I understand that these things are upsetting. Believe me, they make me boil too. I don't stop thinking about it day and night. So, when they come to bump heads or say something against it, I receive it. Just bring something substantial, something with "meat," not "The doctors said it's okay." You can call this vaccine the*

*“release vaccine.” From what does it release us? From the drop of faith that we had in all of these bodies (scientists), that they really want (desire) for our benefit. That they are really coming....*

*What am I coming and saying? Look, let's say that one of the big politicians hears me now. Take it to your interest. There is a Jew here. He is concerned, very. He is expressing the opinions of many people who are also concerned like this. Obviously. You have a lot of professors. Come. Just as now I brought a drop of research. Something. Come before the public. Say ADE. Come, we will explain to you what ADE is. How is it that with Corona there isn't ADE? Put me to ease. Put others to ease. Nobody will do that. Because they are going against the whole world. There is an entire scientific world. Why do you think that we, Israel...? Look.... What is happening today in the world with the vaccines? We are running forward. Our percentages are higher than anywhere else in the world. Or let's say that there are estimations that 40 in 100 get vaccinated. I think that's a little high, but we are definitely first place in the world. In England 10 in 100 get vaccinated. In the United States, 7 out of 100. But in Italy where the big commotion was, 2 out of 100, 2%, They don't want to get vaccinated. In Canada 2/100 and in China, how many in China, the source of all the commotion? There hasn't been corona there for half a year and they aren't even buying vaccines. One out of one hundred get vaccinated there. Switzerland 2, Germany 2, France 1.5, Israel 46.7%, what happened?*

*Now I will say my small opinion. Everything that is happening here is very confusing. A lot of people are talking. Each one says their opinion to here or there. What I say, let's say that I don't know anything. One thing I do know, there is a concern. There is a risk? And against what is it standing? Concern for corona? For death? We don't see*

*it. We don't see it. Thank God, we don't see it. We don't see it. There are percentages of deaths which are not at all alarming. Not in my opinion. The professors, the sociologists, all those who are investigating these things. Meaning, what I am saying, I am reminding the public of the previous clip where I brought graphs to show. What do they show, those graphs? That in every year in the last ten years in the world there is an increase in the percentage of deaths. Today it stands at 58,700,000 people. Every year it goes up 1.2% in the world. This year, 2020, 0.7, meaning a decline in the increase of deaths in the world, a decline. What does it mean? According to the data that they say, there needed to be here another 1.8 million deaths from corona. There should have been a 2.5% increase. This year it is 0.7, meaning where are the deaths from corona in the world? Again, these aren't my opinions. Ask those who made these graphs. They are the very organized bodies that get down to the death of an individual person. In Israel, it's true, in the last months we see an increase in the number of deaths. Not very dramatic. Think why? But in 2020 the numbers of the regular flu, maybe just a little bit more. Real numbers, friends. The numbers of a regular flu, maybe just a little bit more. Real numbers friends. Read the numbers, the numbers speak for themselves. So why run? Why get vaccinated now? Let's do it in half a year maybe. Let's see what happens.*

*Why should the Swiss and the Chinese use us for guinea pigs to see what happens? They know all of these things, trust me. In France, they are scared to get vaccinated. There is public rebellion against it. Why? Because people read in English. We aren't Latin. We don't read English. So, I think, slowly, slowly, don't be in a rush. This is protecting a soul, Maybe. For that, maybe it's worth to wait. There is no*

*catastrophe in the streets. People aren't dying in the streets. So that's all. To wait. God should help, that we should aim at the truth, that God should be with us.*

*There is one more thing that I want to say. I want to say. People ask why are you speaking against the big Rabbis? I am using this opportunity to say, what am I next to the big Rabbis? Nothing. Dirt. Ash and dirt. Next to them in the Torah and Halacha, I am nothing. I don't speak words of Jewish Law and I am not an adjudicator and I don't say my opinions on Torah issues. I don't have anything. What do I have? A little bit of knowledge in medicine, and this is what I bring. But a big Rabbi has to give a ruling based on the opinions of doctors. I am not a licensed doctor, but I work with medicine. When 99 doctors say like this one says like that..... Read what it says in the halacha (Jewish Law). I say the opposite. Correct. I am saying the opposite. I am not coming to rule for Rabbis and not in place of Rabbis. And everyone who does what the Rabbis tell them in merit of that, they should be protected, with God's help. I pray that it will be like that. But I need to give my opinion, otherwise I sin. "Thou shalt not stand on the blood of your friend." "Thou shalt not stand on the blood of your friend." According to everything that we are seeing God should help and protect and save the nation of Israel and we should have a salvation quickly, with God's help.*

Even if this vaccine doesn't contain nanobots or other things that are said to be in it, it will still wreak havoc on your immune system. Like the rabbi mentioned, it will mess with your immune system in a way that to keep healthy you will have to receive a booster, for how long, nobody can tell. And as I mentioned earlier, what if, sometime down the road, the vaccine causes your body to think that your cells are an invader and your lymphatic system starts to attack the normal tissues in your body? If the rabbi is right, and there are indications that he is, then

missing a booster, or if they deny that you need a booster, could mean that even the simplest infection anytime in the future can attack your body with such fury that you will eventually die. Imagine getting a splinter or a simple cut on your hand, it would kill you. Those who are advocating for perpetual mask use might know something that we don't give them credit for. Oregon's governor said that the mask mandate might never go away. Does she know something that we aren't being told? Will this cause the next flu season to be the deadliest ever? Will a biological warfare lab somewhere in the world "accidentally" release another pandemic? A planned depopulation of the Earth would not happen in one fell swoop. It will come in waves so that it looks like an act of nature and not a plan by the Elites to rid the world of us.

There is another Torah-related reason why I refuse the vaccine. Let me try to explain the Torah. The Torah (Christians call it The Law) is a contractual agreement between Yahweh and His People, The Jews. The deal was that if we obeyed the Torah (instruction) and followed the ritual sacrifices in the Torah, Yahweh would cover the sins of the sinner and the Nation of Israel. In addition, the Torah is a contractual agreement between the People of Israel. Many Torah laws talk about being responsible for wronging someone, and, trying to make amends to the party that one might have wronged or damaged. So where does the COVID-19 vaccine fit into all of this?

Several years ago the pharmaceutical companies lobbied Congress to write laws that would make those companies not culpable for damages that a vaccine could cause. In other words, you cannot sue Big Pharma for any damage that one of their vaccines might cause. This is a violation of the Torah which states that everyone, from the richest Priest to the lowest of the peasant had to obey, in that they recompense the party that they have harmed or damaged. The party that takes the vaccine thus is unwittingly writing off their chance of being recompensed for anything that the vaccine might do to harm him or her. Taking the vaccine causes you to consent

to their terms, which is something that I refuse to do. And why else would Big Pharma try to pursue congressmen and senators to write such legislation? It is because they know that the vaccines are dangerous and they know that they would be sued out of existence if that law didn't exist. It's akin to exonerating Josef Mengele for his war crimes and letting him practice as a physician.

One thing that I found (although I'm not surprised about it) is that most of the information on the internet that disputes the safety of the vaccine has been removed from many of the search engines. Even the search engine DuckDuckGo is mostly devoid of information that shows the dangers of taking the vaccines. They have been replaced by websites by entities like the CDC, WHO, John Hopkins, and lest I forget to mention the Mayo Clinic has made it a personal crusade to fact-check and debunk any information that shows that the vaccine is dangerous.

I have personally run into things like this in the past. When I submitted articles to MUFON (Mutual UFO Network) that showed that the event is spiritual, my articles were always declined. When I spoke with Joe Jordan in Roswell in 2008 we presented the Aliens as fallen angels and we put them on a mock trial. This angered many of the secular UFO researchers who tried to mock us during a round table discussion afterward, only to have their questions answered in such a way that they could not dispute our intent and our material. The result was that the secular UFO researchers told the City of Roswell that if Joe or I ever spoke at an event again in Roswell, they would not come to the July celebration. OF course, the city bowed to their demands because these researchers bring a lot of money into Roswell during the event, the event doubling the population of Roswell for a week or two in July.

What have I proved here? I have proved that just because people have diplomas or recognition from a medical association, an epidemiological degree or they've gone through religious training, they sometimes refuse to acknowledge the truth, or suppress it. Right now there is a lot of money to be made off of this Plandemic, from the lowliest doctor to the directors of governments and pharmaceutical companies. Where religion is concerned, the Church is held hostage by its 501c3 mandate from the government. You protest COVID-19 and the IRS pulls your status because they say that you're taking a political stand, something that 501c3 organizations promise not to do. Rabbis outside of Israel fear retribution from civil authorities as they have for thousands of years. Unfortunate for them, when the COVID-19 mRNA vaccine starts to kill people, the favorable stance of the vaccine administration will be seen as just another part of the "Great Zionist Conspiracy," even though the rabbinic opinions killed Jews and not Christians or secular people. Inside Israel rabbis wield a lot of power among the population. It would not surprise me if I heard someday that many of Israel's rabbis were promised money or power by the government when they complied with the government.

The rabbi that I originally corresponded with stated that it was a Mitzvah to take the vaccine. I see no difference between him saying what he did and the rabbis in Germany in the 1930s telling their people to comply with the Nazis because it will be a good thing. Yes, it is a Mitzvah to stay alive. It is a Mitzvah to be around for family, to raise and nurture children and grandchildren in the ways of Yahveh. It is a Mitzvah to stand on the city wall and to raise the alarm when the enemy is seen approaching. It is a Mitzvah to find disfavor within the medical community for raising awareness and expressing caution about a vaccine that could lead to the death of hundreds of millions of people. I will end this with quoting scriptures from the Tanakh:

*Where there is no vision, the people perish: but he that keepeth the law, happy is he.*

*Proverbs 29:18*

Leviticus Chapter 16 tells us not to mix kinds (AKA Species) and that doing so is a sin. Placing the Messenger RNA into your body allows your cells to take in that RNA and it changes your DNA. By disobeying Yahveh you become a Chimera.

*My people are destroyed for lack of knowledge: because thou hast rejected*

*knowledge...Hosea 4:6*

Lack of knowledge is no excuse. Yahveh has given us Torah to read and it instructs us in what is right and what is wrong. On the last day, or if you depart this life because of the vaccine, remember there are no excuses in Torments or Paradise.

*See, I have set before thee this day life and good, and death and evil; In that I command thee this day to love the Lord thy God, to walk in his ways, and to keep his commandments and his statutes and his judgments, that thou mayest live and multiply: and the Lord thy God shall bless thee in the land whither thou goest to possess it. But if thine heart turn away, so that thou wilt not hear, but shalt be drawn away, and worship other gods, and serve them; I denounce unto you this day, that ye shall surely perish, and that ye shall not prolong your days upon the land, whither thou passest over Jordan to go to possess it. I call heaven and earth to record this day against you, that I have set before you life and death, blessing and cursing: therefore choose life, that both thou and thy seed may live: That thou mayest love the Lord thy God, and that thou mayest obey his voice, and that thou mayest cleave unto him: for he is thy life, and the length of thy days:*

*that thou mayest dwell in the land which the Lord swore unto thy fathers, to Abraham, to Isaac, and to Jacob, to give them. Deuteronomy 30:15-20*

Yahveh mentions here the penalty for serving other gods. Scientists, whether they are Goyim or say that they are Jewish, who say that this vaccine is beneficial are prophets of the god of Science, and that is not Yahveh. If you follow their direction, you do not follow Torah. Yahveh has so much love that he granted you a right to disobey him should you wish. Did you ever stop to realize that the rabbis that are telling you not to take this vaccine are the rabbis that follow Torah? The rabbis that are telling you that it is okay to take the vaccine, that it is a Mitzvah, and that a Mitzvah wipes out Torah commands follow the Talmud first and the Torah second. We have discussed above why they have made their decision to follow government dictates and not Torah Instruction. Yahveh has made it quite clear that if you allow Him to instruct you through Torah and you listen and follow, you will live a happy and abundant life. It is your choice.

When we read Leviticus 16 Yahveh tells us not to mix livestock because he saw it as a corruption of the species. When you read Torah some of the Instructions seem a little harsh. Why would Yahveh instill harshness upon His people? Could it be that these things were done before and that they were done in ancient times, times before the Flood of Noah? The Book of Jasher has interesting text in Chapter four that explains deeply the reason for the Great Flood:

*And every man made unto himself a god, and they robbed and plundered every man his neighbor as well as his relative, and they corrupted the earth, and the earth was filled with violence. And their judges and rulers went to the daughters of men and took their wives by force from their husbands according to their choice, and the sons of men in those days took from the cattle of the earth, the beasts of the field, and the fowls of the*

*air, and taught the mixture of animals of one species with the other, in order therewith to provoke the Lord; and God saw the whole earth and it was corrupt, for all flesh had corrupted its ways upon earth, all men and all animals. And the Lord said, I will blot out man that I created from the face of the earth, yea from man to the birds of the air, together with cattle and beasts that are in the field for I repent that I made them. Jasher 4:18-19*

This is also referred to in the Book of Jubilees, Chapter Five:

*And lawlessness increased on the earth and all flesh corrupted its way, alike men and cattle and beasts and birds and everything that walks on the earth -all of them corrupted their ways and their orders, and they began to devour each other, and lawlessness increased on the earth and every imagination of the thoughts of all men (was) thus evil continually. And God looked upon the earth, and behold it was corrupt, and all flesh had corrupted its orders, and all that were upon the earth had wrought all manner of evil before His eyes. Jubilees 5:2-3*

Yahveh has a reason for everything he does and says. Corruption of genetic pools occurred before the flood and he was extra careful to forbid it from happening within Israeli society of that day. Luke, in his Gospel's 17<sup>th</sup> Chapter, mentions a peculiar happening at the return of Yeshua:

*And as it was in the days of Noe, so shall it be also in the days of the Son of man. They did eat, they drank, they married wives, they were given in marriage, until the day that Noah entered into the ark, and the flood came, and destroyed them all. Likewise also as it was in the days of Lot; they did eat, they drank, they bought, they sold, they planted, they*

*builded; But the same day that Lot went out of Sodom it rained fire and brimstone from heaven, and destroyed them all. Even thus shall it be in the day when the Son of man is revealed. Luke 17:26-30*

In ancient Semitic societies, only women were given in marriage, not men. Luke's description suggests that upon the return of Yeshua to Earth, homosexuality will run rampant, It may go a step further, however, suggesting that it may involve creating Chimera from animals or fallen angels, which was common before the flood. We might well see animal hybrids and Nephilim again in this or the next generation.

Getting back to choices that one can make, there is also another choice that you can make that is beneficial and is following the Tanakh. That choice is to realize that you, although you follow the Torah, cannot follow it completely, it is virtually impossible. Since 70CE we have no way to atone for our shortcomings. When the Beit Ha Mikdash was destroyed animal propitiation was ended. It ended about 35 years before that when the Lamb of El was put to death to atone for all of our sins. The rabbis tell us that prayer and good works are the way to attain eternal life, but that is not found in the Tanakh, not in one place. It is a Talmudic legend. The only way to have peace with El Elyon is through His Sacrifice, which he provided for us in the person of Yeshua Ha Mashiach. Study the scriptures. Study Isaiah 52 and 53 and also 61. Study the book of Daniel a book that gives the exact time when the Lamb of God would put an end to transgression. The rabbis have hoodwinked us for two millennia. You don't have to stop being Jewish, you can become a completed Jew, one complete and in fellowship with Yahveh. If you want to push the envelope of research, read the Gospel of Matthew, a Jewish gospel written for Jews as is the Gospel of John. Read the Book of Hebrews, an excellent book for those that want to see how Yeshua fits into Judaism and completes us here in this linear reality.

If this research has confirmed things for you then good. If it has offended you, likewise, good. I don't believe in candy-coating research that is serious and means the difference between life and death, both physical and spiritual. Research isn't meant to make you feel good. It is meant to present the truth, whether it is the truth you want or a truth that you despise. I have done what I felt compelled to do, so I have been successful in either case. I hope and pray Yahveh's best for you, especially that you make the right decisions in life, especially now that you have all of the information, not just one side.
