

YHVH'S NUREMBERG TRIALS

In the middle of the last century there were perilous times. I think that if any one word would be used to sum up the 20th Century, it would be Pride. One little scripture in Proverbs tells us all about pride, and what its wages are:

Pride goeth before destruction, and an haughty spirit before a fall. Better it is to be of an humble spirit with the lowly, than to divide the spoil with the proud. Proverbs 16:18-19

We see the ultimate picture off “pride” in the being that came into opposition with Yahweh because of this being’s pride. We know him as Lucifer (aka Satan). Let’s look at his exhibition of pride, shall we?

*How art thou fallen from heaven, O Lucifer, son of the morning! how art thou cut down to the ground, which didst weaken the nations! **For thou hast said in thine heart, I will ascend into heaven, I will exalt my throne above the stars of God: I will sit also upon the mount of the congregation, in the sides of the north: I will ascend above the heights of the clouds; I will be like the most High.** Yet thou shalt be brought down to hell, to the sides of the pit.*

They that see thee shall narrowly look upon thee, and consider thee, saying, Is this the man that made the earth to tremble, that did shake kingdoms; That made the world as a wilderness, and destroyed the cities thereof; that opened not the house of his prisoners? All the kings of the nations, even all of them, lie in glory, every one in his own house. But thou art cast out of thy grave like an abominable branch, and as the raiment of those that are slain, thrust through with a sword, that go down to the stones of the pit; as a carcase trodden under feet. Thou shalt not be joined with them in burial, because thou hast destroyed thy land, and slain thy people: the seed of evildoers shall never be renowned. Isaiah 14:12-20

Lucifer, after his fall came to Chava in the Garden of Eden and perpetuated the same lie to her in order to get her to disobey Yahweh. Some will say that he appealed to her sense of “pride,” but we have to wonder since pride is a sin, did pride exist before the fall of mankind; or, did Lucifer appeal to her sense of curiosity. Either way, she and Adam both disobeyed. Eve however disobeyed most likely because she wanted to be as a god.

For God doth know that in the day ye eat thereof, then your eyes shall be opened, and ye shall be as gods, knowing good and evil. Genesis 3:5

This one act of disobedience resulted in the fall of mankind and the subsequent misery and rebelliousness of the Human Race for the past 5000+ years. The queen mother of all periods of war and genocide however was the 20th Century. Rough estimates of those killed either in war or by direct genocide are hard to pin down, but adding up rough numbers yields the following statistics:

Killed in wars (civil and multinational): 165,000,000. Yes, that's 165 million people.

What is the main source of warfare and genocide? Well there are land claims, insults, rights and sometimes religion. Note that when going through the data it was humanist ideology that led to a vast majority of the conflicts, sometimes done and blamed on religion. If you slap the "religion" tag on humanism then it was all religious philosophy. Humanism is a religion; it elevates mankind to deity. Many wars were started by humanism fighting other religions or humanists fighting other humanists.

When it comes to other factors causing wars, such as land claims and insults and rights it is simple to see. Nation one is envious that nation two has good land is is prosperous. The heart of nation one says that it isn't fair that nation two has so much and nation two has nothing. Conquer nation two and take the assets. The same thing rights are concerned; "you have no right to be happy and prosperous while I'm sitting here in a bad state, I'll just conquer you and take what you have." Where insults are concerned, things vary, but the scenario could be, "I'm offended that you are being prosperous while you're letting me, your neighbor languor in my misery." It is always the have not's lusting after what others have, or the have's wanting more.

Probably the biggest crime against humanity that occurred in the last century was the plight of people who fell under the influence of the Nazis in Europe. Untold numbers of innocent people perished simply because they were not Aryans or of Aryan descent. Numbered in those victims were the people who underwent horribly unspeakable torture in the Nazi practice of conducting medical and psychological "research" to supposedly learn about the human anatomy and psyche and supposedly "better" humankind.

At the end of World War Two the governments of the world learned about the atrocities of Nazi Germany and they were so appalled that they conducted a long court procession known as the Nuremberg Trials. During the trials many Nazis were found guilty of war crimes. Some were hanged, some were shot and others received life sentences in prison. Part of the focus was on the war crimes where physical and mental experiments were conducted by doctors and other professionals. People were flayed alive so as to see how much pain a person could endure. Nobody will ever know the extent of the cruelty that the Nazis exhibited toward prisoners, but we do know of the following:

Experiments on twins

Experiments on twin children in concentration camps were created to show the similarities and differences in the genetics of twins, as well as to see if the human body can be unnaturally manipulated. The central leader of the experiments was Josef Mengele, who from 1943 to 1944 performed experiments on nearly 1,500 sets of imprisoned twins at Auschwitz. About 200 people survived these studies. The twins were arranged by age and sex and kept in barracks between experiments, which ranged from injection of different dyes into the eyes of twins to see whether it would change their color to sewing twins together in attempts to create conjoined twins.

Bone, muscle, and nerve transplantation experiments

From about September 1942 to about December 1943 experiments were conducted at the Ravensbrück concentration camp, for the benefit of the German Armed Forces, to study bone, muscle, and nerve regeneration, and bone transplantation from one person to another. Sections of bones, muscles, and nerves were removed from the subjects without use of anesthesia. As a result of these operations, many victims suffered intense agony, mutilation, and permanent disability.

Head injury experiments

In mid-1942 in Baranowicze, occupied Poland, experiments were conducted in a small building behind the private home occupied by a known Nazi SD Security Service officer, in which "a young boy of eleven or twelve [was] strapped to a chair so he could not move. Above him was a mechanized hammer that every few seconds came down upon his head." The boy was driven insane from the torture.

Freezing experiments

In 1941, the Luftwaffe conducted experiments with the intent of discovering means to prevent and treat hypothermia. There were 360 to 400 experiments and 280 to 300 victims indicating some victims suffered more than one experiment.

Another study placed prisoners naked in the open air for several hours with temperatures as low as -6°C (21°F). Besides studying the physical effects of cold exposure, the experimenters also assessed different methods of rewarming survivors. "One assistant later testified that some victims were thrown into boiling water for rewarming."

The freezing/hypothermia experiments were conducted for the Nazi high command to simulate the conditions the armies suffered on the Eastern Front, as the German forces were ill-prepared for the cold weather they encountered. Many experiments were conducted on captured Russian troops; the Nazis wondered whether their genetics gave them superior resistance to cold. The principal locales were Dachau and Auschwitz. Dr Sigmund Rascher, an SS doctor based at Dachau, reported directly to Reichsführer-SS Heinrich Himmler and publicised the results of his freezing experiments at the 1942 medical conference entitled "Medical Problems Arising from Sea and Winter". Approximately 100 people are reported to have died as a result of these experiments.

Malaria experiments

From about February 1942 to about April 1945, experiments were conducted at the Dachau concentration camp in order to investigate immunization for treatment of malaria. Healthy inmates were infected by mosquitoes or by injections of extracts of the mucous glands of female mosquitoes. After contracting the disease, the subjects were treated with various drugs to test their relative efficiency. Over 1,000 people were used in these experiments and more than half died as a result.

Immunization experiments

At the German concentration camps of Sachsenhausen, Dachau, Natzweiler, Buchenwald, and Neuengamme, scientists tested immunization compounds and serums for the prevention and treatment of contagious diseases, including malaria, typhus, tuberculosis, typhoid fever, yellow fever, and infectious hepatitis.

Mustard gas experiments

At various times between September 1939 and April 1945, many experiments were conducted at Sachsenhausen, Natzweiler, and other camps to investigate the most effective treatment of wounds caused by mustard gas. Test subjects were deliberately exposed to mustard gas and other vesicants (e.g. Lewisite) which inflicted severe chemical burns. The victims' wounds were then tested to find the most effective treatment for the mustard gas burns.

Sulfonamide experiments

From about July 1942 to about September 1943, experiments to investigate the effectiveness of sulfonamide, a synthetic antimicrobial agent, were conducted at Ravensbrück. Wounds inflicted on the subjects were infected with bacteria such as Streptococcus, Clostridium perfringens (the causative agent in gas gangrene) and Clostridium tetani, the causative agent in tetanus. Circulation of blood was interrupted by tying off blood vessels at both ends of the wound to create a condition similar to that of a battlefield wound. Infection was aggravated by forcing wood shavings and ground glass into the wounds. The infection was treated with sulfonamide and other drugs to determine their effectiveness.

Sea water experiments

From about July 1944 to about September 1944, experiments were conducted at the Dachau concentration camp to study various methods of making sea water drinkable. At one point, a group of roughly 90 Roma were deprived of food and given nothing but sea water to drink by Dr. Hans Eppinger, leaving them gravely injured. They were so dehydrated that others observed them licking freshly mopped floors in an attempt to get drinkable water.

Sterilization experiments

The Law for the Prevention of Genetically Defective Progeny was passed on 14 July 1933, which legalized the involuntary sterilization of persons with diseases claimed to be hereditary: weak-mindedness, schizophrenia, alcohol abuse, insanity, blindness, deafness, and physical deformities. The law was used to encourage growth of the Aryan race through the sterilization of persons who fell under the quota of being genetically defective. 1% of citizens between the age of 17 to 24 had been sterilized within 2 years of the law passing. Within 4 years, 300,000 patients had been sterilized. From about March 1941 to about January 1945, sterilization experiments were conducted at Auschwitz, Ravensbrück, and other places by Dr. Carl Clauberg. The purpose of these experiments was to develop a method of sterilization which would be suitable for sterilizing millions of people with a minimum of time and effort. These experiments were conducted by means of X-ray, surgery and various drugs. Thousands of victims were sterilized. Aside from its experimentation, the Nazi government sterilized around 400,000 people as part of its compulsory sterilization program. Intravenous injections of solutions speculated to contain iodine and silver nitrate were successful, but had unwanted side effects such as vaginal bleeding, severe abdominal pain, and cervical cancer. Therefore, radiation treatment became the favored choice of sterilization. Specific amounts of exposure to radiation destroyed a person's ability to produce ova or sperm. The radiation was administered through deception. Prisoners were brought into a room and asked to complete forms, which took two to three minutes. In this time, the radiation treatment was administered and, unknown to the prisoners, they were rendered completely sterile. Many suffered severe radiation burns.

Experiments with poison

Somewhere between December 1943 and October 1944, experiments were conducted at Buchenwald to investigate the effect of various poisons. The poisons were secretly administered to experimental subjects in their food. The victims died as a result of the poison or were killed immediately in order to permit autopsies. In September 1944, experimental subjects were shot with poisonous bullets, suffered torture and often died.

Incendiary bomb experiments

From around November 1943 to around January 1944, experiments were conducted at Buchenwald to test the effect of various pharmaceutical preparations on phosphorus burns. These burns were inflicted on prisoners using phosphorus material extracted from incendiary bombs.

High altitude experiments

In early 1942, prisoners at Dachau concentration camp were used by Sigmund Rascher in experiments to aid German pilots who had to eject at high altitudes. A low-pressure chamber containing these prisoners was used to simulate conditions at altitudes of up to 20,000 m (66,000 ft). It was rumored that Rascher performed vivisections on the brains of victims who survived the initial experiment. Of the 200 subjects, 80 died outright, and the others were executed.

For the past seventy years society has been very outspoken about the atrocities committed by the Nazis, and rightfully so. However, in the past four decades there has been a trend to refute the crimes of the Nazis as being a fabrication, especially where the genocide against the Jews is concerned. Society tends to become numb as years pass, especially with the passing of the generation that fought against Fascism in the 1940's. I see it as deliberate that as the number of veterans has diminished gradually over the years the doctrine of Holocaust denial has increased. This is natural because the lesser the amount of people to testify about the facts that a holocaust occurred, the bolder the deniers of the Holocaust becomes because there are less and less witnesses against them.

We can see the same sort of trend when it comes to abortion, both here in the United States in countries around the world where infanticide is legal. Early in the Twentieth Century abortion was an unspeakable act. It was committed by doctors that lived in the shadows and by women with no scruples. During that time if society found out that someone received an abortion that person was usually castigated and scorn. If a doctor was found to have performed an

abortion procedure they lost their license and could never work again. As the years progressed, and the generation that opposed abortion started to die out the opposition was replaced by a “look the other way,” when it came to abortion procedures. People started to sympathize with a “woman’s plight,” accepting abortion more as the years progressed. With the advent of feminism and the “woman’s right to choose,” and “it’s my body,” mentality the acceptance of abortion picked up steam. In 1979 the United States Supreme Court decided that abortion was a legal procedure, opening up the tidal wave that would result in, as of 2015, 57,496,011 innocent children having been murdered.

It seems that where bad things are concerned, it is more convenient for people to put things out of their minds so that they do not have to think about them. The evils of the Nazis are being dismissed or forgotten and with the Islamic and Neo-Nazi campaign to dismiss history and/or turn it around to seem like a lie, the public is being educated to believe Kool-Aid that they are being served. Similarly, abortion is being presented as an ethical procedure. Also shared between Nazism and abortion rights people is the doctrine that their victims are not human. Abortions insist that until a baby is born, he or she is not a human being; labeling them as a fetus or in the case of the younger in-vivo citizens, they are referred to as inviable life forms. Inviability is defined as “not able to survive,” which presents a problem for just about every life form on earth. Take any adult human, strip them down and drop them at the North Pole during winter and that person is inviable; they will freeze to death. Drop any human dead center in the Pacific Ocean without any flotation device and they become inviable because sooner or later they will lose the energy to maintain buoyancy and they will drown.

Many will look back at Nazi Germany and say that what they did was evil. Well, they killed scores of people, not just Jews, but Gypsies, the infirm, the mentally infirm, and innumerable numbers of people that opposed the evils that they were performing. Where the Jewish population was concerned, the Nazis simply classified them as nonhuman. When a person is dehumanized, they are much easier to kill because the act changes from murder to euthanasia. People are murdered, animals are euthanized. Many will say that the Germans broke the law by committing murder on innocents. Well, if you dehumanize a person and change the law to reflect that Jews must be killed because they are not humans, then technically the Germans were not breaking their own laws. Now look at abortion; the same thing has happened. Unborn babies are termed “fetus” and/or inviable tissue,” and the law is changed to allow them to be killed. Do you see the parallels here?

So, are there any more parallels? When Jews and others were rounded up, they were robbed of their belongings. When the Allies liberated the concentration camps, they found piles of eyeglasses, clothes and shoes. In addition, the allies found that the Nazis were making products using the body parts of their victims. It is common knowledge that the skin of their victims was used as lampshades and their hair was used to weave into products. Their teeth were extracted if they had gold or silver fillings and those fine metals were melted down and sent to the Nazi treasuries. Recently the American public was able to view hidden camera footage where members of Planned Parenthood actually admitted to selling the body parts of aborted children. Do you see the parallels here?

I started out by writing about the Nuremberg Trials; how Nazis were rounded up and tried for their crimes. Some, like the infamous Dr. Mengele escaped and lived life on the run in South America. For the most part, the worse of the worse were tried for their crimes. Many were hanged or shot and some served out life sentences, or committed suicide. The sad part is that except for a scant few, most of them did not repent of their evils and most went to their death proud of the evil that they perpetuated. The thing is except for a few, the Nazis were tried for their crimes. Will there be a parallel for those who perform abortions and those who willfully choose to commit the crime? The answer is yes, there will be justice for the tens of millions of babies that have been murdered by the hands of our modern-day Dr. Mengele's.

The problem is that the nations that prosecuted the Nazis for their crimes are now the ones that offer abortion legally. It seems like there is no one who could bring this evil to justice. Well, there isn't anyone in this world currently who can prosecute those who murder hundreds of thousands or millions of babies every year. The nations of this world, specifically the United States have become the Nazi State that they once fought to free the world from tyranny. Unlike most nations in this world, the United States was founded on Biblical principles.
